The Fonds pour la Science, la Technologie et l'Innovation (FONSTI) is a research support fund designed to finance high quality scientific research and technological innovation programmes and projects likely to have a beneficial impact on the socioeconomic and cultural development of the Ivory Coast. Placed under the supervision of the Ministry of Higher Education and Scientific Research, FONSTI supports collaborations between public research communities as well as public-private partnerships in order to stimulate knowledge production.

The mission of FONSTI is to:

- Finance national research programmes as well as scientific and technological research projects by allocating resources to researchers;
- Contribute to the scientific, economic and social valorisation of research results;
- Provide support to research structures in terms of rehabilitation of stations and laboratories, acquisition of research equipment and access to scientific information;
- Disseminate scientific and technological information;
- Protecting research achievements through intellectual property;
- Strengthen the capacities of researchers;
- Supporting the mobility of researchers;
- Promote entrepreneurship in higher education and research institutions;
- Conducting studies and surveys in relation to the national scientific and technological research system;
- Encouraging and promoting international cooperation in scientific research.

FONSTI has been a regular and active participant in the GRC since 2016 and the GRC African regional meeting in Abidjan, and FONSTI Secretary General, Dr. Yaya Sangaré has been serving in the GRC Governing Board since 2018. In this same year, FONSTI organised the annual meeting of the Science Granting Councils Initiative in sub-Saharan Africa (SGCI).

Founded in 2012, amidst a conference on Merrit Review at the National Science Foundation in Washington, the Global Research Council, GRC, is a virtual organisation, comprised of the heads of science and engineering funding agencies from around the world. Since its creation, the GRC has enabled heads of science and engineering funding agencies from around the world to come together to discuss common issues and promote the sharing of data and best practices, with the aim of promoting high-quality international research collaboration.

In the last 12 years the science and research ecosystem has changed substantially as have the challenges being faced by societies globally, exemplified by the cases of climate change and pandemics. Among others, these two events did lay out the need for stronger and more effective international collaboration among public research funding agencies.

GRC has strongly increased in legitimacy and reach, as the 273 registered delegates to the 2024 Annual Meeting in Interlaken, Swiss, stemming from 51 countries and 58 agencies bear witness.

The GRC has also responded to societal challenges, addressing the funders perspective, by creating three working groups to engage and produce action on topics such as Equity Diversity and Inclusion (EDI-WG), the Responsible Research Assessment (RRA-WG) and Multi-lateral Engagement (MLE-WG). It has also brought current discussion topics such as the role of research in sustainability to a series of Regional Meetings worldwide and, finally, to this Annual Meeting, where a Statement of Principles of Research and Sustainability shall be endorsed by participating agencies.

Many opportunities and further challenges lie ahead of the GRC, which include the improvement of the collaboration strategies among its participating agencies as well as the interaction with other stakeholders of the global research ecosystem, aiming to make the funders perspective heard outside the GRC community.

The need to strengthen the legitimacy of science before global societies by involving more diverse actors in the science and research endeavor is constantly pointed out as a necessary step to fulfill the GRC mission and objectives.

I understand the Programme presented at the Annual Meeting 2024 in Interlaken represents a significant step towards fulfilling the GRC Mission and Objectives.

The EDI Working Group continues the work of the Gender Working Group formed in 2017 to contribute to implementing the Statement of Principles and Actions: Promoting the Equality and Status of Women in Research (endorsed in 2016). As of 2023, to accommodate the increased mandate, the Gender Working Group was renamed EDI Working Group. The group is guided in its deliberations, activities, and strategic planning by the idea that broadening participation and practicing

inclusive analysis contributes to research and innovation. It promotes gender equality from an intersectional perspective, considering the overlapping of gender with other dimensions of inequality, such as race, ethnicity, socioeconomic status, disability, and geographical location. On that basis, the EDIWG is advancing the following initiatives.

- Promoting the integration of an equity, diversity, and inclusion lens into the design of the GRC's vision for the next ten years, strategic planning, road map, and annual themes.
- Striving to integrate relevant EDI considerations in GRC-developed programs, resources, and future work streams.
- Working to build knowledge and provide strategic and transformative analysis and advice to the GRC and the member organizations on an ongoing basis.

Responsible Research Assessment Working Group

The Global Research Council (GRC) Responsible Research Assessment (RRA) working group, was established in 2021 following the endorsement of a Call to Action calling on participant organisations to embed RRA principles and take concrete action to incentivise and fulfil RRA ambitions. The group has the following key objectives:

- To advocate globally for the importance of RRA and work towards a shared understanding and goal for RRA within GRC participants.
- To share practice and guidance in implementing and embedding RRA in GRC participants.
- To galvanize support and enable coordinated action in GRC participants to implement common RRA principles and frameworks across the global research system.
- To extend the knowledge base where gaps and barriers persist or emerge, building on existing work where possible.

What we have delivered

- Produced an Action Plan which details our objectives and our work strands.
- We have worked towards a shared understanding and goal for RRA within GRC participant organizations with the creation of the Dimensions for RRA.
- We have launched a 2024 survey on RRA of GRC participant organisations in collaboration with the Research on Research Institute. This will help us to understand the current state of play and reflect on changes in RRA from 2020 (when the last survey was conducted). Your organisation will be invited to participate in the survey which will close in August 2024.

What we will do next

- Analyse and produce a working paper on the results of the 2024 GRC RRA survey.

 - Share how funders have implemented and embedded RRA.

- Develop a self-assessment tool and supporting roadmap for funders.
